The History of the Titusville Amateur Radio Club

When I wrote last month about updating the website, I mentioned that each step in that process seemed to spawn yet another unexpected step. The most recent step was updating the Club's history section. To do that I had to dig through two decades of TARC newsletters (June 1988 - June 2007) and seven years of stand-alone minutes (2014 -2021). The President's Corner in the newsletter provided a monthly snapshot of club activities. The minutes, although helpful, were less informative since they only chronicled what was discussed at the monthly meeting.

The Titusville Amateur Radio Club Handbook for New Members (1994) also provided a wealth of information. Note that the history presented on the website is a less detailed version of the history presented below. The website version is intended for folks who are

looking for background information Hurricane Betsy (1965) using Gonset and are probably not familiar with specific individuals and locations.

The following is a compilation of my notes from the sources mentioned above. A copy of this information will be retained in the Club's archive and will be updated when new information becomes available.

The Titusville Amateur Radio Club (TARC) began as an informal group in the mid-1950s. Most members of this group worked in the early space program at Kennedy Space Center or Cape Canaveral Air Force Station. They gathered in each other's home after work for social and technical sessions. Eventually, Harold Weir (K4RLK) built a room on the back of his house for Club meetings. The Club provided emergency communications during Hurricane Donna (1960) and Continued on Page 2

Communicator two meter (VHF), amplitude modulation (AM) transceivers. Eventually, as the member's families grew up and other outside activities became available, the Club declined.

In early 1970s, Fred McKenzie (K4DII) manually compiled a list of hams in the 32780 (Titusville) Zip Code area using the Amateur Radio Callbook. Fred Kienzle (K4ZS) and two other hams used that list to contact local hams and revive TARC. They got 35 interested people to come to their first, renewed club meeting. With a lot of help from Les Griner (K4SJC), Bill Hoskinson (K4CUO), Bud Hughes (K4CWG) and several others, TARC was reformed in 1976.

The History of TARC — Continued

TARC grew steadily over the years and supported many local causes including the Titusville Christmas Parade, Mims Christmas Parade, Race for the Cure (cancer), Cross Florida Bicycle Tour, Sun Day Challenge, Apollo Motorcycle Club, Space Shuttle launch viewing sites along the Indian River lagoon, Titusville Fourth of July fireworks shows, the Indian River Festival raft race, Valiant Air Command Air Show, Run For Life (women's shelters), Space Coast Cycle Club, and Tour de Cure (diabetes). TARC provided communications in support of the city of Titusville and Brevard County during emergencies (mainly hurricanes). As of 2024, many of these events are no longer in existence while others now use their own communications resources.

In 1990, TARC became an ARRL affiliated club and became an incorporated organization in Florida. Also, TARC acquired the use of Post Office Box 73 in Titusville, Florida.

The TARC "Mosquito Net" was started by Carole Ann Ramos (KC4VIN) in 1991 as a way to promote the use of the ten meter band. At one point there were over 930 net members in all 50 states and 15 countries. The Net is still active, albeit with fewer participants.

The first TARC hamfest was held in conjunction with the Experimental Aircraft Association fly-in at Arthur Dunn Air Park in October 1991. Hamfests were held annually through 1998 at Dunn Air Park, Fox Lake Park, or Sand Point Park. In 1999, TARC voted to hold two tailgates per year (March and November) in place of the annual hamfest in November.

In August 1994, TARC was granted tax exempt status as a 501(a) organization; however, that status was revoked in 2010.

TARC received its original club call sign, KC4CFN, in September 1995. In November 2003, KC4CFN was replaced with the current club callsign, K4KSC.



Denman Road Repeater Bidg

TARC has operated the 146.91 MHz repeater since the mid 1980s and the 146.97 MHz repeater since the early 1990s. Both repeaters are located in Titusville. "The 91 repeater was not part of the club. Larry Skidmore (WB4LOE) owned the repeater and in the summer of 1977 he sold it to the "Dirty Dozen" - 12 local hams who put up the money to buy it. The repeater remained independent of the club and operated as the Titusville Repeater Association. Fred McKenzie (K4DII) had the 97 repeater but it was open to local hams. The 67 repeater was operated by Coffey Coffman (WOLRC) and it was also open to locals. In the mid 1980s the Titusville Repeater Association was merged into TARC and remains in that status at this time. Larry gave the 97 repeater to the club in the fall of 1991 after obtaining the frequency from K4DII.", per Les Widick (K4BZJ). The club also had a packet node and a UHF repeater, but they are no longer in operation. The 146.91 MHz repeater had an Echolink interface in 2007. The 146.775 MHz repeater in Mims has been in operation since 2001. In 2024, it was updated to operate exclusively on solar power. As of 2024, the 146,775 MHz repeater was located near Denman Road in Mims, the 146.91 MHz repeater was located at Roy (N4RKM) and Stephanie (K4MVO) Merritt's home in northwest Titusville, and the 146.97 MHz repeater was atop Titusville Towers in

TARC has participated in Field Day in every year for which we have records. Operating locations were Draa Field (now the site of the Brevard County Schools bus parking compound), Miracle City Mall (now the site of Titus Landing), Sand Point Park, Fox Lake Park, and City of Titusville well field #3 (south of Highway 50 and east of Barna Avenue). In 2001, there were two Field Day sites - in Titusville at well field #3 and in Mims near Denman Road.

Fox hunts were a popular Club activity from early 1991 until May 1998. Additionally, TARC occasionally participated in fox hunts sponsored by the Daytona Beach Amateur Radio Association.

Weekly "eating meetings" are a TARC tradition. Locations included Beef O'Brady's, Denny's, Good Thymes, Howard Johnson's, International House Of Pancakes (on US 1), Jalopy's, Kelsey's, Loyd Have Mercy, Morrison's Cafeteria, New York New York, Quincy's, Sadie's, Sambo's, and Village Inn.

The Club's membership peaked at almost 300 members 1995. In 2024, there were 56 members.
